The vehicle was impounded and the suspect was arrested for Felony possession under 18, Felony Firearms- serial number-obliterate/remove/change , Felony Firearm-serial number receive/possess/alter, and felony possession of a firearm with prior felony conviction. The suspect was booked into the Hennepin County Juvenile Detention Center.
