The suspect, a 41 year old male, was observed on security footage stealing merchandise valued at \$1,167.30. The vehicle used in the theft also registered to the suspect. After reviewing the videos, this case was referred to the Ramsey County Attorney for the charges of felony theft and felony possession of shoplifting gear.</p>

Employees obtained the license plate number of the suspect's vehicle. The suspect left the cart with some of the stolen merchandise still in the cart. The recovered merchandise was valued at \$60.58. Investigation identified the suspect was a 31 year old male. This case was referred to the city attorney to charge the suspect, via formal complaint, for misdemeanor theft.</p>

An ambulance was called and the suspect was transported to the hospital for evaluation. The area was checked but the suspects were not located. The recovered merchandise was valued at \$529.10. This case is pending further investigation.
