ALLEGED MISCONDUCT FOR CALENDAR YEAR 2013

MN STAT 626.8457, subd. 3, requires Chief Law Enforcement Officers (CLEOs) to annually report summary data regarding the investigation and disposition of cases involving alleged unprofessional conduct by peace officers based on your department's allegations of misconduct policy (MN RULES 6700.2200). Your department's policy should minimally require the complainant to complete and sign a citizen complaint form for the complaint to be considered filed. The policy should also allow the CLEO the discretion to determine whether or not the facts alleged require a formal investigation.

Failure to disclose or providing false information may result in disciplinary action against the CLEO's license. Please submit completed form to the POST Board by Friday, October 3, 2014.
