The driver appeared intoxicated and failed the preliminary breath test. She was placed under arrest for driving while intoxicated. She received a reading of .16 alcohol concentration on the breath test. The driver was booked at the Hennepin County Jail for gross misdemeanor 3rd degree DWI, 3rd degree alcohol concentration over .08, misdemeanor underage drinking and driving, and leaving the scene of an accident.
