When officers arrived, one of the victim's was attempting to restrain the suspect. The suspect had to be physically restrained by officers. After questioning, officers determined that the suspect, a 14 year old male, had threatened his mother, a 40 year old female, with a knife. At this time, a 33 year old male, intervened and disarmed the suspect. The suspect began physically assaulting the adult male and started chocking him. Due to a threat to kill himself, the suspect was placed in custody and transported to the hospital for care. All were advised that this case would be referred to Ramsey County Attorney's Office for felony domestic assault strangulation and felony 2nd degree domestic assault with a weapon.
