The suspect was booked at the Ramsey County Jail for felony 1st degree possession of a controlled substance (500 grams or more), felony 5th degree possession of a controlled substance, felony flee police in a motor vehicle, felony obstructing-risk of death or bodily harm, misdemeanor flee in other than a motor vehicle, and driving after revocation.
