Officers attempted a high risk stop, but vehicle sped away, crashing through the closed garage door.	Yes	1 White Male 1 White Female	No

7-7-2021	Medical	Soft Hands	Officers called to a female in a vehicle who "looked to be tweaking out." Female appeared to be in medical emergency or under the influence of a controlled substance. 7-26-2021	Stolen Vehicle Warrant	Soft Hands	Officers attempting to arrest a suspect for possession of a stolen vehicle and active warrants. Suspect pulled away and began to flee on foot. 9-26-2021	Person in Crisis	Soft Hands	Resident's adult son was at their home against their wishes. He was reportedly under the influence of methamphetamines. Officers used soft hand techniques to place him in handcuffs.	Yes	1 White Male	No

11-11-2021	Person in Crisis	Soft Hands	Caller reported a male standing in the middle of the road, throwing his coat down, appearing to be in crisis. Officers were familiar with the subject, who had a history of illicit drug use and admitted to recent drug use. His speech was rapid, he was disassociated with reality, and refused to remove himself from the roadway. Officers dialogued with him for over an hour. Officers signed an emergency transport hold, but subject refused to comply. Officers used soft hand techniques to assist him into the ambulance.	Yes	1 White Male	No
11-12-2021	DWI Arrest	Soft Hands	An officer stopped a vehicle and observed the driver to show obvious signs of impairment, likely by alcohol. Checks of the license plate revealed it was the subject of an alert by another police agency, though officers did not know the particulars of the alert. As officers approached, the vehicle engine started. Officers disengaged, initiated a high risk stop procedure, and gave verbal commands. Occupants complied. 12-24-2021	Medical	Soft Hands	Caller wanted her ex-boyfriend brought to the hospital, after he had been mixing alcohol with pills and was becoming belligerent. Caller was scared of her ex-boyfriend when he is intoxicated. When officers told the subject that he needed to go to the hospital, he became enraged. He took swings at officers and took a fighting stance, chest to chest, with one officer. Officers used a takedown technique to lower the subject to the ground, during which time he continued to struggle and refused handcuffs.
