Officers approached the suspect vehicle, as the driver was attempting to back into the garage, and observed heavy damage to the front. The driver was identified as a 62 year old male who resided at the address. The driver was placed under arrest for driving while intoxicated. He received a reading of .15 alcohol concentration. The driver had two previous DWI convictions in the last 10 years and was booked at the Hennepin County Jail for gross misdemeanor 2nd degree DWI, 2nd degree alcohol concentration over .08, and leaving the scene of an accident.

Estimated loss value of the property recovered in the suspect's vehicle was \$100. Both suspects will be mailed a trespass notice.
