This same vehicle was located by Roseville PD and again fled. That pursuit was discontinued. The second vehicle, came back as stolen out of Richfield. Another Roseville squad observed this vehicle and it again fled. St. Anthony officers blocked Silver Lake Road as the vehicle sped on 29th at speed in excess of 90mph into Minneapolis. The area was checked, neither vehicle was located.
